 property tax levies for Fiscal Year 2019/2020. Garrett explained that District Staff is working with Gila County
 concerning this issue. The NGCSD has received its total property tax levy for Fiscal Year 2019/2020 and is not
 affected by this situation. District Staff will continue to monitor on a monthly basis. No action was taken by
 the Board.
- TOP July 4th, Fireworks, future options due to cancellation of event Garrett Goldman provided options to the Board for the Fiscal Year 2019/2020 budget allocation for the TOP July 4th Fireworks, which were

- cancelled due to the COVID-19 emergency. A motion was made by Shirley Dye to leave the funds with the TOP as a credit for the TOP July 4^{th} , 2021 Fireworks event. Due to the credit, the Board would like to table the discussion regarding uses of the FY 2020/2021 TOP July 4^{th} Fireworks event budget allocation. - NGCSD COVID-19 response, regarding disconnect procedures and late fees Garrett Goldman presented billing/delinquent/disconnect notices statistics for the months of February, March, April, May and June 2020.
